RELEASE, ASSUMPTION OF RISK, WAIVER OF LIABILITY, AND INDEMNITY AGREEMENT SIGNATURES REQUIRED AT EACH X BELOW UNSIGNED ENTRIES WILL NOT BE ACCEPTED.

CAREFULLY READ THIS AGREEMENT BEFORE SIGNING AS YOU ARE WAIVING SIGNIFICANT LEGAL RIGHTS

Every entry made on this entry blank shall constitute an agreement and affirmation that all participants (which shall include, without limitation, the owner, lessee, trainer, manager, agent, coach, driver, rider, handler, as spectator and the horse) for themselves, their principals, representatives, employees, and agents: Shall be subject to the rules of the Foundation for the Pure Spanish Horse (hereinafter called "The Foundation") and the 2108 US OPEN Celebration Horse Show.

Represent that every horse, rider, driver and handler is eligible as entered. Fees paid to the Foundation for the Pure Spanish Horse or 2108 US OPEN Celebration Horse Show represent a donation to the Foundation for the Pure Spanish Horse; Agree to be bound by the rules of the Foundation for the Pure Spanish Horse and 2108 US OPEN Celebration Horse Show, and will accept as final the decision of the hearing committee on any question arising under said rules, and agree to hold The Foundation for the Pure Spanish Horse, its officers, directors and employees harmless for any action taken;

Agree that they participate voluntarily in the competition fully aware that horse sports and the competition inherently have dangerous risk of serious injury or death am fully aware and acknowledge that horse sports and The Foundation activities involve inherent dangerous risks of accident, loss and serious bodily injury including, but not limited to, broken bones, head injuries, trauma, pain, suffering, or death ("Harm"). I fully understand that this r _____ release covers, but is not limited to, inherent risks of an equine activity which mean a danger or condition that is an integral part of an equine activity, including but not limited to, any of the following:

The propensity of an equine to behave in ways that may result in injury, death, or loss to persons on or around the equine. The unpredictability of an equines reaction to sounds, sudden movement, unfamiliar objects, persons, or other animals:

Hazards, including, but not limited to, surface or subsurface conditions; A collision with another equine, another animal, a person, or an object: The potential of an equine activity participant to act in a negligent manner that may contribute to injury, death, or loss to the person of the participant or to other persons, including but not limited to, failing to maintain control over an equine or failing to act within the ability of the participant.

And by participating they expressly assume and all risks of injury or loss, and agree to indemnify and hold the Foundation for the Pure Spanish Horse, 2108 US OPEN Celebration Horse Show, Great Southwestern Equestrian Center, Newberry, Florida, and the State of Texas and their officers, directors, employees and agents, harmless from and against, all claims including for any injury or loss suffered during, or in connection with, the competition, whether or not such claim, injury or loss resulted, directly or indirectly, from the negligent acts or omissions of said officers, directors, employees or agents of the Foundation for the Pure Spanish Horse and the he 2108 US OPEN Celebration Horse Show.

I AGREE to release The Foundation, its successors or assigns, officials, officers, directors, employees, agents, personnel, volunteers, affiliated organizations from all claims including but not limited to, claims for money or property, disability, covenants, actions, suits, causes or action, obligations, debts, costs, expenses, attorneys fees, judgments, orders, and liabilities of whatsoever kind or nature in the law, equity or otherwise, whether now known or unknown, suspected or unsuspected, and whether concealed or hidden, including but not limited to any state of federal statutory or common law claim or remedy of any kind whatsoever arisen out of in any way connected with any Harm to me or my horse and for any Harm caused by me or my horse to others, even if the Harm resulted, directly or indirectly, from the negligence of The Foundation or The Foundation activity.

I AGREE to expressly assume all risks of Harm to me or my horse, including Harm resulting from the negligence of The Foundation or The Foundation activity, and **specifically agree to the applicable state statute/law regarding equine/farm animal activity liability and signed posting, (if any), in any state in which I or my child participants in The Foundation activity. A true copy for all state statutes in effect at the time of the execution of this agreement shall be acknowledged by both parties as if set out fully in the text of this document.**

I AGREE that neither I, nor any one claiming through me, will hereafter bring, commence, prosecute or maintain, or cause to permit to be brought, commenced, prosecuted or maintained, any suit or action, either at law or in equity, in any court in the United States or in any state thereof, or elsewhere, against The Foundation, its successors or assigns, for, on account of, arising out of, or in any way connected with any Harm to me or my horse, and that neither I, nor any one claiming through me will enforce, prosecute, or recover upon, or attempt to enforce, prosecute or recover upon, any claim or right of action whatsoever, which I, or any one claiming through me, may now have or hereafter assert, in any way connected with claims for Harm to me or my horse, and for claims made by others for any Harms caused by me or my horse at The Foundation activity.

I AGREE this Agreement is the entire agreement of the parties, and supersedes all prior oral and written understandings, and agreements. This Agreement may be modified only by a written amendment signed by both parties.

I AGREE that if any provision of the Agreement is found to be invalid or illegal by a court of competent jurisdiction, the remaining provisions shall be construed as if the affected provision had not been included in order to effectuate the intent of the parties.

In the event this form is signed by the parent/guardian of a child, then all representations and acknowledgements herein are expressly made by, for, and on behalf of the parent/guardian and child.

By signing below, **I AGREE** to be bound by all applicable Foundation rules and all terms and provisions of The Foundation activity. I acknowledge that I enter into this release after having read the same, and place my signature hereto of my own free voluntary act and deed. By signing below I represent to The Foundation that I fully understand its contents that I do not need any further explanation, and I waive any further explanation.
